**Important Notice for the Candidates of fourth Round of
Counselling**

Candidates of fourth round of NIMCET 2021 counselling are hereby notified that the document verification in the fourth round of counselling will commence from tomorrow i.e.

06-10-2021 (Wednesday) and will continue upto 11-10-2021 (Monday).

The candidates who have not been allotted the seats in any of the previous three rounds and have been allotted seat in fourth round only (i.e. fresh candidates) are required to pay a fees of Rs. 10000/- **on or before 07-10-2021 (Thursday).** The candidates who had earlier surrendered their seats need not pay Rs. 10000/- at this stage. The fresh candidates after payment of the prescribed fees of Rs. 10000/- and the candidates who had earlier surrendered their seats have to either lock their choice of allotted Institute or they can surrender the seat if they are not satisfied with the allotted Institute. The candidates who lock their choice of allotted Institute can download their provisional admission letters. At the same time, the candidates who don't exercise any of the two options will be assumed to have exercised the 'lock' option.

The mode of reporting viz. online or offline will be communicated by the Institute to the candidates. The candidates are therefore advised to visit their registered e-mail id frequently and they are directed to do as informed by the allotted Institute.

Since this is an timebound process, candidates MUST strictly adhere to the activity timelines as mentioned above.

If a candidate fails to report the allotted Institute within the time limit or fails to submit the required documents at the time of admission then his admission can be cancelled by the concerned Institute for which neither the concerned participating NIT nor NIMCET 2021 shall be responsible.

Important Points:

➤ The following options **must be** exercised by the candidates after the fourth round of allotments along-with mandatory online payment of the initial fee of Rs. 10000/- (to be paid by fresh candidates only):

- **Acceptance of the allotted seat, Option-1:** Candidates who wish to finalize the seat allotted to them and wish to join in the institute allotted to them and take the Provisional Admission Letter.
- **Surrender, Option-2:** Candidates who wish to surrender the seat allotted to them.

However, if a candidate fails to exercise either of the above options, then he/ she will be considered to have exercised Option-1 (Acceptance of the allotted seat).

- Due to closure of University/Colleges and offices due to COVID-19, the candidates who did not have their mark-sheets/grade-sheets and valid OPEN-EWS or OBC Certificates were allowed to upload undertaking(s) instead, at the time of form filling. All such candidates must produce these documents at the time of verification of the documents.
- If a candidate produces a category certificate, during the verification of the documents, afresh (i.e., having applied as OPEN candidate earlier and having appeared in the NIMCET-2021 test as OPEN candidate), his category will **NOT BE CHANGED** and any claim of change in category will not be entertained.
- The candidate **must produce the valid OPEN-EWS/OBC/PwD certificate(s) at the time of document verification**, failing which the seat allotted to candidate in OPEN-EWS / OBC/PwD category can be cancelled.
